

Your Technical Institution (Engineering/Pharmacy/MBA) filed an application to All India Council for Technical Education (AICTE) for grant of extension of approval for the Academic Year (AY) 2015-16, wherein, you have specified the courses for which approval is sought for including the particulars of availability of faculty, laboratory equipment etc. This application has been submitted to AICTE along with an affidavit affirming the particulars furnished in the application, on Non-Judicial Stamp paper.

On perusal of your application, the AICTE granted approval on the basis of selfdisclosed required facilities and infrastructure of the College for the courses specified in Table-1 herein. On the basis of approval of AICTE, your college submitted an application to the University (JNTUH) for grant of affiliation for the courses specified in Table-2 The University had inspected your College for verification of faculty and laboratory equipment and the University found deficiencies of faculty, laboratory equipment and accordingly affiliation was refused for the deficient courses.



Your College filed Writ Petition along with some other colleges questioning the action of the University in not granting the affiliation for the courses which were rejected affiliation. Against the order, the University filed Writ Appeal with the Division Bench of the Hon'ble High Court which has directed the AICTE to inspect the colleges once again for verification of faculty and laboratory equipment and constituted a Committee consisting of two nominees from AICTE and one from the University (hereinafter referred to "Committee"). But, however, your College has confined the inspection of the Committee to courses specified in Table-3 herein.

The Committee had inspected your College and submitted a report. On scrutiny of the said report, the University found the deficiencies specified in Table-4 herein.

In view of the deficiencies specified in Table-4 i.e., essential requirements for conducting courses, the University is granting / rejecting your application for affiliation of courses. The particulars set out in Table-1, 2, 3 & 4 may be read as part of this order.
